

- Good oral and written communication skills unaffected by speech impediments.
- Good interpersonal skills to enable them to maintain adequate customer services.
- Reasonable physical strength and agility, including the ability to repeatedly lift and carry baggage or bend, reach, stoop, squat, stand for prolonged.
