

(**)Annual Escalation of 10% on Bid value from 2nd-year shall be applied as per the policy of AAICLAS from time to time.

Note:

- (i) Offer below MRLF will not be considered for award.
- (ii) The Quoted licence fee against MRLF shall be subject to annual compound escalation
- (iii) The successful tenderer is liable to pay all Govt. Taxes including GST @18%
- (iv) Gestation period of thirty (30) or actual commencement of commercial operation whichever is earlier, will be permitted
- (v) The gestation period will be counted from the date of issuance of letter of intent / award to the successful bidder.For cases of all the contracts that have been extended or the contract is bagged by the same party and the subsequent award letter is ipso facto extension of the contract as far as the period is concerned, no gestation period will be granted.

The licensee has to ensure all the compliances including security compliances etc. within the gestation period itself. Claim for additional gestation period or rebate on account of any non-compliance by the licensee within the gestation period shall not be entertained by AAICLAS at any stage.

- (vi) The prospective bidders are requested to go through the tender conditions and visit the site/ airport to assess the feasibility of business / undergo proper diligence study and thereafter may bid in the Tender. No reduction in license fee will be entertained by AAICLAS at any stage for whatever reasons.
- (vii) Participants are advised not to give any conditional tender and adhere to the terms and conditions indicated in the tender documents provided by AAICLAS. Conditional tenders would be summarily rejected.
- (viii) The successful tenderer has to ensure that the Police verification/antecedents Verification of their employees as per guidelines of BCAS is available before applying for Airport Entry Passes in favour of their employees. Charges applicable for issue

of Airport Entry Passes of their employees shall be borne by the licensee.

2. The period of licence shall be Three (03) Years

Important Note:

The Period of license shall remain 'THREE YEARS' with the provision that in the event the AAICLAS (Authority) transfers the rights to operate and maintain the Cargo to a third party(s) under PPP mode, AAICLAS shall ensure that

(a) Authority shall cause to transfer/novate this Agreement, in favour of such third party on the principle that such transfer/novation would release Authority of all liabilities and obligations arising from and after the date of transfer / novation of such rights. The Parties, along with relevant third party(s) shall execute necessary documentation or put in place necessary agreements for the aforesaid transfer/novation; and

(b) The rights and obligations under or pursuant to all contracts and other arrangements entered into in accordance with the provisions of this Agreement between Authority and licensee shall be vested in such third party.

3. Eligibility / Experience Criteria :-

Parties having minimum of 01 (Year) years of experience in handling such contracts with the municipality / MES / Cantonment Board / hospitals / hotels / flight kitchens / PSU / Airports / seaport / railways.

Documentaryshreds of evidences establishing these requirements/criteria must be submitted by the bidders/tenderers at the time of tender.

4. Only one e tender document shall be sold to a single party either a firm or an individual. Theroprietor of more than one company or firm will be considered as single party and one Legalentity.
5. Any party either a firm or an individual falling under the following categories is not eligible:
- (a) Debarred/black listed by CBI or AAI/ AAICLAS or Undertakings/ Departments like; Railway, Defence, orany other Department of Govt. of India, State Govt. Deptt. etc. A declaration to this effect is also to be submitted by the party with tender documents.
 - (b) Parties facing action under PPE Act, with AAI/ AAICLAS
 - (c) Parties either an individual or a business establishment, who has been ordered by a Court of Law to pay the outstanding dues of AAICLAS at any of the airports as a whole and has not Paidsuch dues to AAICLAS shall also not be eligible for the e tender.
 - (d) Ex-Licensee(s)/Existing Licensee(s) of AAI/ AAICLAS having outstanding dues in respect of the airports under Northern, Southern, Western, Eastern and North-East Regions as well as Airports viz. Chennai and Kolkata Airports except where the dues are pertaining to current months licence fee i.e the month of May, 2016. The disputed dues referred to an arbitrator for adjudication as per terms


and conditions of the licence agreement shall not form a part of outstanding dues for the purpose of the acceptance of tender documents.

6. The tendering process is online at e-portal URL address <https://etender.gov.in./eprocure/app> or <https://aaiclas-ecom.org>. Aspiring bidders may download and go through the tender document.

Prospective Tenderers are advised to get themselves register at CPP-portal, obtain 'login ID' & 'Password' and go through the instructions available in the Home Page after log in to the CPP-portal <https://etender.gov.in./eprocure/app> or aaiclas-ecom.org. They should also obtain Digital Signature Certificate (DSC) in parallel which is essentially required for submission of their application. The process normally takes 03 days' time.

1. E-Tendering Participation Requirements :-

Interested bidders / tenderers willing to participate through e-tendering process are required to register themselves on this portal followings the process given below :

1.1 User Name and Password :-

The objective of obtaining system generated user identification

(UID) followed by Password is essential for downloading of e-tender document. The e-tender document is uploaded by AAICLAS using digital signatures. However, digital signature is not required for down loading of e-tender document. The portal can be viewed through guest user (id) for getting tender details & other information at portal.

1.2 Cost of tender fees amounting to Rs.4,000/- (Rupees Fou thousand), shall be paid by the bi before the scheduled time of e-tender submission through RTGS/NEFT in favor of 'AAI Cargo Logistics & Allied Services Co Ltd' No other mode of payment shall be acceptable.
